



**ABCD Expedited Certification  
For Pediatric Dentists Only**

Pediatric dentists receive extensive formal educational training in early childhood oral health. Therefore the completion of the 3-hour ABCD continuing education course, ***Oral Health for Infant and Toddlers*** is not required for ABCD certification but is always recommended. General dentists must review the ABCD curriculum, attend a county-specific orientation, and complete billing training from DSHS/HRSA prior to being ABCD certified by the University of Washington.

- have a National Provider Identification (NPI) number, obtained from the Centers for Medicare & Medicaid Services
- be registered in ProviderOne, Washington's Medicaid provider payment system
